**ORDINANCE NO. 8280**

**AN ORDINANCE** FURTHERMORE AMENDING SECTION 2.a. OF ORDINANCE NO. 7755, AS AMENDED BY ORDINANCE NO. 7944, BY INCLUDING THEREIN ADDITIONAL LOADING AND UNLOADING AREAS OF THE CRISTOBAL TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, BY INCREASING ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a. of Ordinance No.7755, as amended by Ordinance No. 7944, is hereby furthermore amended by adding letters b, c and d, to read as follows:

**“CRISTOBAL TRICYCLE OPERATORS AND DRIVERS ASSOCIATION,  
INC. (CRISTODA)**

**Loading and Unloading Areas**

- a. Cristobal Street near the corner of United Nations Avenue
- b. West Berlin Street near the corner of Cristobal Street
- c. Gen. Luna Street near the corner of Gonzales Street
- d. Paz Street near the corner of Perdigon Street”

**SEC. 2.** Sec. 2. of Ordinance No. 7871, is hereby further amended by increasing the Route Measure Capacity of CRISTODA from 40 units to 75 units, and by deleting the word “CORNER” and appending therein the Authorized Route Line, as amended, to read as follows:




**SEC. 3. EFFECTIVITY CLAUSE.** – This Ordinance shall take effect upon its approval.




