

ORDINANCE NO. 8286

AN ORDINANCE APPROPRIATING THE AMOUNT OF TEN MILLION, TWO HUNDRED EIGHTY-FIVE THOUSAND, TWO HUNDRED NINETY-THREE PESOS AND THIRTY-EIGHT CENTAVOS (PHP10,285,293.38) OUT OF THE REVERSION OF APPROPRIATION INTENDED FOR EXPROPRIATION OF LOT UNDER ORDINANCE NO. 7976, ENACTED ON DECEMBER 21, 1999, DULY PREPARED BY THE CITY TREASURER AND APPROVED BY THE CITY ACCOUNTANT, AS GENERAL FUND SUPPLEMENTAL BUDGET NO.1, TO BE MADE AVAILABLE AS PARTIAL PAYMENT OF JUST COMPENSATION

Be it ordained by the City Council of Manila, in session assembled, THAT:

SEC.1. There is hereby appropriated from the General Fund, sourced from the Reversion of Appropriation to the General Fund, and which is not otherwise appropriated, the sum of Ten Million, Two Hundred Eighty-Five Thousand, Two Hundred Ninety-Three Pesos and Thirty-Eight Centavos (PhP10,285,293.38), as General Fund Supplemental Budget No.1, and which budget documents, marked as Annex "A," for Statement of Funding Sources (LBP Form No. 9), and Annex "B," for Statement of Supplemental Appropriation (LBP Form No.10), are attached and made integral parts hereof, to be made available as additional appropriation of the City Government of Manila for Fiscal Year 2012.

The herein appropriation of fund represents the authorized supplemental budgetary support for the partial payment of just compensation for the heirs of the Late Justice Jose B.L. Reyes on property converted into city streets:

Realignment/Reversion

Reversion of appropriation intended for expropriation of Lot, under Ordinance No. 7976 (Annual Executive Budget FY 2000)

SEC.2. This matter was originally covered by Resolution No. 47, Series of 2012, authorizing the Chief Executive to release the funds allocated for this purpose; subsequently, payment thereof was approved under Ordinance No. 8279 enacted on June 28, 2012; and eventually, funds are finally appropriated under this Ordinance.

SEC.3. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 11, 2012.
