**ORDINANCE NO. 8286**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF TEN MILLION, TWO HUNDRED EIGHTY-FIVE THOUSAND, TWO HUNDRED NINETY-THREE PESOS AND THIRTY-EIGHT CENTAVOS (PHP10,285,293.38) OUT OF THE REVERSION OF APPROPRIATION INTENDED FOR EXPROPRIATION OF LOT UNDER ORDINANCE NO. 7976, ENACTED ON DECEMBER 21, 1989, DULY PREPARED BY THE CITY TREASURER AND APPROVED BY THE CITY ACCOUNTANT, AS GENERAL FUND SUPPLEMENTAL BUDGET NO.1, TO BE MADE AVAILABLE AS PARTIAL PAYMENT OF JUST COMPENSATION**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SEC.1.** There is hereby appropriated from the General Fund, sourced from the Reversion of Appropriation to the General Fund, and which is not otherwise appropriated, the sum of **Ten Million, Two Hundred Eighty-Five Thousand, Two Hundred Ninety-Three Pesos and Thirty-Eight Centavos (PhP10,285,293.38)**, as General Fund Supplemental Budget No.1, and which budget documents, marked as **Annex "A,"** for Statement of Funding Sources (LBP Form No. 9), and **Annex "B,"** for Statement of Supplemental Appropriation (LBP Form No.10), are attached and made integral parts hereof, to be made available as additional appropriation of the City Government of Manila for Fiscal Year 2012.

The herein appropriation of fund represents the authorized supplemental budgetary support for the partial payment of just compensation for the heirs of the Late Justice Jose B.L. Reyes on property converted into city streets:
