AN ORDINANCE CREATING THE PERSONS WITH DISABILITIES AFFAIRS OFFICE IN THE CITY OF MANILA, DEFINING ITS FUNCTIONS, AND APPROPRIATING FUNDS NECESSARY THEREFOR

be it ordained by the City Council of Manila, in session assembled, *THAT*

SECTION 1. *Creation.* - There is hereby created a Persons with Disabilities Affairs Office (PDAO), under the administrative and operational control of the Manila Department of Social Welfare.

SEC. 2. *Composition.* - The Community Affairs and Development Section of the Manila Department of Social Welfare, with all its existing plantilla items, shall compose the PDAO.

SEC. 3. *Functions.* - The PDAO is hereby assigned and empowered to perform functions relative to the establishment of their office, viz:

1. Implement fully the provisions of Republic Act 7277, otherwise known as the Magna Carta for Disabled Persons, and Batas Pambansa Blg. 344 in the City of Manila;
2. Gather data/statistics relative to the population of Persons with Disabilities (PWDs) residing in the City of Manila;
3. Propose means to further improve the financial independence of PWDs by initiating production and livelihood sheltered workshops and trainings;
4. Deputize non-governmental and people's organizations to monitor the effective implementation of Republic Act 7277;
5. Study, analyze and carry out schemes that shall promote the general welfare of PWDs in the City of Manila; and,
6. Monitor and regulate fund-raising activities and solicitation involving PWDs as beneficiaries.

SEC. 4. *Budget.* - The amount of Ten Million Pesos (PhP 10,000,000.00), or so much thereof, as may be necessary, shall hereby be annually appropriated to finance the operation of PDAO.

SEC. 5. *Annual Report.* - The PDAO shall submit an annual comprehensive report on the operation of the office, including statistics, programs, and projects to the Office of the Mayor and the City Council.

SEC. 6. *Separability Clause.* - If any part or provision of this Ordinance shall be held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.


SEC. 7. *Repealing Clause.* - All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SEC. 8. *Effectivity Clause.* - This Ordinance shall take effect immediately upon its approval.




This Ordinance was finally enacted by the City Council of Manila on October 23, 2012.
