ORDINANCE NO. 8292

AN ORDINANCE AUTHORIZING THE CITY MAYOR TO CAUSE THE ACQUISITION EITHER BY NEGOTIATION, EXPROPRIATION OR BY ANY OTHER LEGAL MEANS, OF THAT CERTAIN PARCEL OF LAND WITH AN AREA OF TWO THOUSAND SIXTY SQUARE METERS AND FORTY SQUARE DECIMETERS (2,060.40 SQ. M.), MORE OR LESS, LOCATED IN SAN ANDRES, MALATE, BARANGAY 738, ZONE 80, DISTRICT V, MANILA, REGISTERED UNDER THE NAME OF ADELA O. TUASON, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 95260, IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. The City Mayor is hereby authorized to cause the acquisition, either by negotiation, expropriation or by any other legal means, of that certain parcel of land with an area of Two Thousand Sixty Square Meters and Forty Square Decimeters (2,060.40 Sq. M.), more or less, located in San Andres, Malate, Barangay 738, Zone 80, District V. Manila, covered by TCT No. 95260, registered under the name of Adela O. Tuason, in the Registry of Deeds for the City of Manila.

- SEC. 2. The aforementioned parcel of land, sought to be acquired, shall be for the benefit of the bona fide tenants/occupants thereat, particularly the registered members of ADELA O. TUASON NEIGHBORHOOD ASSOCIATION, INC., based in the area, for resale at cost and on installment basis not exceeding twenty (20) years.
- SEC. 3. The amount of Ten Million Pesos (PhP 10,000,000.00) or so much thereof, as may be be necessary is hereby appropriated, out of any unappropriated funds existing in the City Treasury, to be made available for the implementation of the Ordinance.
 - SEC. 4. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on December 4, 2012.
