**ORDINANCE NO. 8297**

**AN ORDINANCE** FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755, (UNDER TRICYCLE TERMINALS) AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF THE DOMINGO ALTURA QUINTOS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED (DOMALQUITODA) AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Under Sec. 2.a (Tricycle Terminals) of the City Ordinance No. 7755, is hereby furthermore amended by including therein the Loading and Unloading Area of the Domingo Altura Quintos Tricycle Operators and Drivers Association, Inc. (DOMALQUITODA) by adding another number, to read as follows:

**“DOMINGO ALTURA QUINTOS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (DOMALQUITODA), INC.**

**Loading and Unloading Area**

a. Domingo Santiago St., near the corner of G. Tuazon St.”

**SEC. 2.** Section 2 of Ordinance 7871 is hereby amended by adding another number to read as follows:

Luisa St., Negros St., Norma St., Samar St., Leyte St., Quintos St., Honrades St., Firmeza St., and vice versa.”


**SEC. 3. Effectivity Clause.** – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 24, 2013.


