AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755, (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF P. GUEVARRA ANDALUCIA LACSON MALABON ALVAREZ STA. CRUZ SONA 34 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (PALMAS SONA 34 TODA) IN P. GUEVARRA STREET, AND LIKEWISE AMENDING SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended by adding another number to read as follows:

Loading and Unloading Areas

- a) P. Guevarra St., corner Tayuman St.
- b) P. Guevarra St., corner Malabon St.
- c) Rizal Avenue corner Malabon St.
- d) Oroquieta St., corner Tayuman St.
- e) San Lazaro St., corner Andalucia St.
- f) Felix Huertas St., corner Tayuman St.”

SEC. 2. Section 2 of Ordinance No. 7871, is hereby amended by adding another number to read as follows:


ROUTE

The authorized route line of operation shall begin in the area of Felix Huertas St. corner Tayuman St., going to the University of Sto. Tomas from Felix Huertas St., left to Maria Clara St., right to Vicente Cruz St., right to Piy Margal St., corner Arsenio Lacson Avenue and “VICE VERSA”. From Pedro Guevarra St., corner Tayuman St., going to Abad Santos Avenue, right to Malabon St., right to Oroquieta St., left to Herrera St., right to Ipil St., and left to Yuseco St., corner Abad Santos Avenue and “VICE VERSA”. From Pedro Guevarra St., going to Blumentritt Market along the side of Malabon St., right to Oroquieta St., going to Laguna St., and/or Old Antipolo St., corner Rizal Avenue and “VICE VERSA”. From Oroquieta St., right to Tayuman St., right to Pedro Guevarra St., left to San Lazaro St., going to Ma. Clara St., corner Maceda St., from Maceda St., right to Dapitan St., straight to Remigio St., left turn to Felix Huertas St., straight to Lope de Vega St., Doroteo St. and Masangkay St. and “VICE VERSA”.


SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 24, 2013.




