**ORDINANCE NO. 8299**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755, (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE TRICYCLE LOADING AND UNLOADING AREAS OF THE OLD STA. MESA BALDOVINO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED (OSMBTODA) AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a of Ordinance No. 7755, is hereby furthermore amended by including therein the Loading and Unloading Areas of Old Sta. Mesa Baldovino Tricycle Operators and Drivers Association, Inc. (OSMBTODA) by adding another number to read as follows:

**"OLD STA. MESA BALDOVINO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (OSMBTODA)**

**Loading and Unloading Areas**

- a. Baldovino St., Sta. Mesa beside SM Center Point
- b. Old Sta. Mesa St., corner Damka St., near Sta. Mesa Drug Store"

**SEC. 2.** Section 2 of Ordinance No. 7871, is hereby amended by adding another number to read as follows:

**ROUTE**

The authorized route line of operation shall begin in the area of Damka St., corner Old Sta. Mesa turning left to Valenzuela Extension straight to Baltao and vice-versa to Damka St., straight to Old Sta. Mesa, turn right to V. Mapa Street turn right to Road 2, enter either Road 1, Hippodromo or Road 4 and from any of the streets mentioned, unit will come to Baldovino St. and vice-versa. Damka St., straight to Old Sta. Mesa Street turn right to V. Mapa Street and right to Guadalcanal Street straight to Old Sta. Mesa."


**SEC. 3. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 24, 2013.




