Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Apitong Street, Sta. Cruz, in the Third District of Manila is hereby renamed Eraño G. Manalo Street.

SEC. 2. The City Engineer of the City of Manila is hereby directed to cause the replacement of the present street signs installed at strategic places thereat as follows:


ERAÑO G. MANALO
(formerly Apitong Street)

SEC. 3. Copies of this Ordinance be furnished the Office of the President, the Office of the Representative of the Third District of Manila, the National Historical Institute, the Philippine Postal Corporation and the City Engineer's Office.


SEC. 4. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on February 14, 2013.




