AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755, (TRICYCLE TERMINALS) AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF MASBATE, DOMINGO SANTIAGO, ALTURA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Sec. 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended by including therein the Loading and Unloading Areas of Masbate, Domingo Santiago, Altura Tricycle Operators and Drivers Association, Inc. (MASDATODA), to read as follows:

"MASBATE, DOMINGO SANTIAGO, ALTURA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (MASDATODA)

Loading and Unloading Areas

- a. Altura St., corner Buenos Aires
- b. Masbate St., corner G. Tuazon St."

SEC. 2. Section 2 of Ordinance No. 7871 is hereby furthermore amended by including therein the Route Measure Capacity and authorized route line of the Masbate, Domingo Santiago, Altura Tricycle Operators and Drivers Association, Inc. (MASDATODA), to read as follows:

Authorized route lines: Altura St., to Masbate St., Balic-Balic St., to Domingo Santiago to Buenos Aires and vice versa."


SEC. 3. Effectivity Clause. - This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on February 21, 2013.
