ORDINANCE NO. 8305

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755, (TRICYCLE TERMINALS) AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF BUENOS AIRES – G. TUAZON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Sec. 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended by including therein the Loading and Unloading Area of Buenos Aires – G. Tuazon Tricycle Operators and Drivers Association, Inc. (BAGTTODA), to read as follows:

“BUENOS AIRES – G. TUAZON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (BAGTTODA)

Loading and Unloading Area

- a. Loading – Buenos Aires Street corner Altura Street, Sampaloc, Manila
Unloading – Domingo Santiago Street corner G. Tuazon Street, Sampaloc, Manila.”

SEC. 2. Section 2 of Ordinance No. 7871 is hereby furthermore amended by including therein the Route Measure Capacity and authorized route line of Buenos Aires – G. Tuazon Tricycle Operators and Drivers Association, Inc. (BAGTTODA), to read as follows;

“ASSOCIATION

RMC

Buenos Aires –G. Tuazon
Tricycle Operators and Drivers
Association, Inc. (BAGTTODA)

70 units

The authorized route line of operation shall be via Buenos Aires Street-Road 10-Domingo Santiago Street and vice versa.”

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


SEC. 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on February 21, 2013.


