AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755, (TRICYCLE TERMINALS) AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF NAVARRA, DAPITAN, TRICYCLE OPERATORS AND DRIVERS ASSOCIATION AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Sec. 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended by including therein the Loading and Unloading Area of Navarra, Dapitan, Tricycle Operators and Drivers Association (NAVADAP-TODA), to read as follows:

“NAVARRA, DAPITAN, TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, (NAVADAP-TODA)

Loading and Unloading Area

- a. Navarra Street corner Dapitan Street, Sampaloc, Manila”

SEC. 2. Section 2 of Ordinance No. 7871 is hereby furthermore amended by including therein the Route Measure Capacity and authorized route line of the Navarra, Dapitan, Tricycle Operators and Drivers Association (NAVADAP-TODA), to read as follows;

<u>“ASSOCIATION</u>	<u>RMC</u>
Navarra, Dapitan, Tricycle Operators and Drivers Association (NAVADAP-TODA)	100 units

The authorized route lines of operation shall be via Navarra Street-Dapitan Street-Rosarito Street-Asturias Street-Antonio Street-Juaning Street-Santander Street – Padre Noval Street – J. Barlin Street- I. Delos Reyes-Eloisa Street - G. Tolentino Street- Laon-Laan Street - Loyola Street – Moret Street- Galicia Street and vice versa.”


SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on February 21, 2013.
