ORDINANCE NO. 8307

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755, (TRICYCLE TERMINALS) AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF PARADISE HEIGHTS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Sec. 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended by including therein the Loading and Unloading Areas of Paradise Heights Tricycle Operators and Drivers Association, Inc., (PHTODA), to read as follows;

"PARADISE HEIGHTS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (PHTODA)

Loading and Unloading Areas

- a. Smokey Mountain Compound
- b. Vitas near the corner of Road 10
- c. SM Hypermarket near the corner of road 10"

SEC. 2. Section 2 of Ordinance No. 7871 is hereby furthermore amended by adding the Paradise Heights Tricycle Operators and Drivers Association, Inc. (PHTODA), to read as follows:

SEC. 3. Effectivity Clause. - This Ordinance shall take effect immediately upon its approval.
