ORDINANCE NO. 8312

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755, (TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF PASIG LINE, ZOBEL, SAMPAGUITA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Sec. 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended by including therein the Loading and Unloading Areas of Pasig Line, Zobel, Sampaguita Tricycle Operators and Drivers Association, Inc. (PALZSATODA), to read as follows:

“PASIG LINE, ZOBEL, SAMPAGUITA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (PALZSATODA)

Loading and Unloading Areas

- a. Sampaguita Street corner Pasig Line
- b. Tejeron Street corner Sampaguita Street
- c. Zobel Roxas Street corner Tejeron Street”

SEC. 2. Section 2 of Ordinance No. 7871 is hereby furthermore amended by including therein the Route Measure Capacity and authorized route line of the Pasig Line, Zobel, Sampaguita Tricycle Operators and Drivers Association, Inc. (PALZSATODA), to read as follows;

Authorized Route Lines: Via Pedro Gil Street – Augusto Francisco Street – Tejeron Street – Pasig Line Street – Sagrada Pamilya Street – Mabuhay Street – Eloriaga Street – Arellano Street – Garido Street – Milagrosa Street – Ligaya Street – Liwayway Street – Hiwaga Street – Sampaguita Street – Zobel Roxas Street.”

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.


This Ordinance was finally enacted by the City Council of Manila on March 21, 2013.


