AN ORDINANCE FURTHERMORE AMENDING SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY CHANGING THEREIN THE ROUTE MEASURE CAPACITY OF ANTONIO MACEDA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2 of Ordinance No. 7871, is hereby furthermore amended by changing therein the Route Measure Capacity of Antonio Maceda Tricycle Operators and Drivers Association (AMATODA), to read as follows:

Antonio Maceda Tricycle Operators and Drivers Association (AMATODA)	A. Maceda-Dimasalang	300 units"


SEC. 2. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SEC. 3. Repealing Clause. - All other local laws, decrees, orders, issuances rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


SEC. 4. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 19, 2013.


