**ORDINANCE NO. 8315**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF MOTHER IGNACIA DEL ESPIRITU SANTO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a of Ordinance No. 7755 is hereby furthermore amended by including therein the Loading and Unloading Areas of Mother Ignacia Del Espiritu Santo Tricycle Operators and Drivers Association, Inc. (MIDESTODA), to read as follows:

**“MOTHER IGNACIA DEL ESPIRITU SANTO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (MIDESTODA)**

**Loading and Unloading Areas**

Loading – corner of España Avenue and F. Cayco Street, Sampaloc, Manila

Unloading – a. corner Alcantara Street and M. F. Jhocson Street, Sampaloc, Manila

b. corner Legarda Street and J. Figueras Street, Sampaloc, Manila”

**SEC. 2.** – Section 2 of Ordinance No. 7871 is hereby furthermore amended by including therein the Route Measure Capacity and authorized route line of Mother Ignacia Del Espiritu Santo Tricycle Operators and Drivers Association, Inc. (MIDESTODA), to read as follows:

**“ASSOCIATION**

**RMC**

Mother Ignacia Del  
Espiritu Santo Tricycle Operators and  
Drivers Association, Inc. (MIDESTODA)

50 units

Authorized route line of operation shall be via F. Cayco Street – M. Earnshaw Street – M.F. Jhocson Street and J. Figueras Street and vice versa.”


**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

**SEC. 4. Repealing Clause.** - All other local laws, decrees, orders, issuances rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect immediately upon its approval.


