AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755, (TRICYCLE TERMINALS) AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF MADRIGAL TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Sec. 2.a of Ordinance No. 7755, is hereby furthermore amended by including therein the Loading and Unloading Areas of Madrigal Tricycle Operators and Drivers Association, Inc., (MATODA), to read as follows:

**"MADRIGAL TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC.
(MATODA)**

Loading and Unloading Areas

- a. Madrigal Extension in front of DBM Building
- b. Paz Guanzon Street In front of Robinsons Mall
- c. Paz Guanzon Street corner Mendiola Extension"

SEC. 2. Section 2 of Ordinance No. 7871 is hereby furthermore amended by including therein the route measure capacity and authorized route line of Madrigal Tricycle Operators and Drivers Association, Inc. (MATODA), to read as follows:

Madrigal Tricycle Operators and Drivers Association, Inc. (MATODA)	Madrigal Compound - Paco Paco – Madrigal Compound. and vice versa	70 units

Authorized Route line: Via Madrigal St. – Cristobal St.- Paz Guanzon St. - Mendiola Extension - Santiago St. – Zamora St.- Ulilang Kawayan St. – Paz St.- Merced St.- Perdigon St. – San Gregorio St. – Leroy St. – Gen. Luna St."

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.
