ORDINANCE NO. 8321

AN ORDINANCE FURTHERMORE AMENDING SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN THE ROUTE MEASURE CAPACITY OF FELIX HUERTAS-YUSECO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2 of Ordinance No. 7871, is hereby furthermore amended by including therein the Route Measure Capacity and authorized route line of Felix Huertas-Yuseco Tricycle Operators and Drivers Association, Inc. (FEL-YUTODA), to read as follows:



The authorized route line of operation shall begin in the area of: (1) SM City San Lazaro Felix Huertas St., left to Laguna St., crossing Rizal Ave., to Anacleto St., T. Mapua St., Makata St., S. Reyes St., Kusang-Loob St., Ipil St., right to Abad Santos, to Tambunting Aurora Blvd., right to L. Rivera St., right to Old Antipolo St., and "VICE VERSA" Route Area (2) SM City San Lazaro Felix Huertas St., Alvarez St., right to Ipil St., left to Quiricada St., right to Tayuman St., left to Ipil St., right to S. Herrera St., crossing Rizal Ave., left to Felix Huertas St., SM City San Lazaro, "VICE VERSA."


SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.


