ORDINANCE NO. 8333

AN ORDINANCE AMENDING SECTION 2 OF THE CITY ORDINANCE NO. 8073, ENTITLED: "AN ORDINANCE AUTHORIZING THE CITY MAYOR TO ACQUIRE EITHER BY PURCHASE, NEGOTIATION OR EXPROPRIATION A PARCEL OF LAND WITH AN AREA OF 6,619.4 SQUARE METERS, MORE OR LESS, COVERED BY TCT NO. 190603, AND REGISTERED IN THE NAME OF YK DEVELOPMENT CORPORATION, FOR AWARDED TO ACTUAL AND BONA FIDE TENANTS AT THE LOWEST POSSIBLE PRICE IN BARANGAY 158, ZONE 14, TONDO II, UNDER THE LAND-FOR-THE-LANDLESS PROGRAM", BY INCREASING THE APPROPRIATED AMOUNT TO TWENTY MILLION PESOS (PHP 20,000,000.00), TO BE CHARGED UNDER THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY UNDER THE 2014 APPROPRIATIONS

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2 of Ordinance No. 8073, entitled: "AN ORDINANCE AUTHORIZING THE CITY MAYOR TO ACQUIRE EITHER BY PURCHASE, NEGOTIATION OR EXPROPRIATION A PARCEL OF LAND WITH AN AREA OF 6,619.4 SQUARE METERS, MORE OR LESS, COVERED BY TCT NO. 190603, AND REGISTERED IN THE NAME OF YK DEVELOPMENT CORPORATION, FOR AWARDDING TO ACTUAL AND BONA FIDE TENANTS AT THE LOWEST POSSIBLE PRICE IN BARANGAY 158, ZONE 14, TONDO II, UNDER THE LAND-FOR-THE-LANDLESS PROGRAM, BY APPROPRIATING THE AMOUNT OF FIVE MILLION PESOS (PHP 5,000,000.00), NEEDED THEREFOR AND FOR OTHER PURPOSES" is hereby further amended to read as follows:

"SEC. 2. The amount of Twenty Million Pesos (PhP 20,000,000.00), or so much thereof as may be necessary, is hereby appropriated out of any available funds in the City Treasury, for the purpose of acquiring the property to be charged under the Land-for-the-Landless Program of the City under the 2014 Appropriations ."

SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 14, 2014.
