**ORDINANCE NO. 8335**

**AN ORDINANCE** EXEMPTING PRIVATE MARKETS WITH FRANCHISE FROM THE CITY GOVERNMENT OF MANILA FROM THE DISTANCE RESTRICTION OF TWO HUNDRED FIFTY METERS (250 M.) WITH CITY- OWNED PUBLIC MARKETS UNDER SECTION 1 OF ORDINANCE NO. 3782, ENTITLED: "AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 3563, BY PROHIBITING THE SALE OF FRESH MEAT WITHIN A RADIUS OF TWO HUNDRED FIFTY METERS FROM ANY CITY PUBLIC MARKET"

Be it ordained by the City Council of Manila, in session assembled, *THAT*:


**SECTION 1.** All private markets with franchise granted by the City Government of Manila are hereby exempted from the distance restriction of Two Hundred Fifty Meters (250 M.) under Section 1 of Ordinance No. 3782 and may, therefore, sell or offer for sale fresh meat regardless of proximity with any public market owned by the City Government of Manila; *PROVIDED*, That such meat underwent inspection with a certification issued by a veterinarian from the Veterinary Inspection Board attesting that the animals furnishing the meat passed ante-mortem and post-mortem examinations and were found fit for human consumption; *PROVIDED FURTHER*, That such meat has been kept for a period of less than twenty (20) days in any establishment equipped for cold storage purposes.

**SEC. 2.** All ordinances or parts thereof, which are inconsistent with this Ordinance, are hereby repealed or modified accordingly.


**SEC. 3. Effectivity Clause.** – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 21, 2014.
