Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a. of Ordinance No. 7755 (under Jeepney Terminals), is hereby furthermore amended by including therein the loading and unloading areas of Dasmariñas – Divisoria Jeepney Operators and Drivers Association, Inc., to read as follows:

"Dasmariñas-Divisoria Jeepney Operators and Drivers Association, Inc.


Loading and Unloading Areas
