## ORDINANCE NO. <u>8370</u>

AN ORDINANCE AMENDING THE TITLE AND SECTION 1 OF ORDINANCE NO. 8257, ENTITLED: "AN ORDINANCE EXPROPRIATING A CERTAIN PORTION OF A PARCEL OF LAND, SITUATED AT ESTERO DE CONCORDIA, PEÑAFRANCIA AND ZAMORA STREETS IN PACO, FIFTH DISTRICT OF MANILA, OWNED BY SPOUSES CARLITO AND LIGAYA OSTANI, REGISTERED UNDER TRANSFER CERTIFICATE OF TITLE NO. 213633, MEASURING APPROXIMATELY 3 METERS BY 12 METERS, TO BE UTILIZED AS RIGHT-OFWAY BY RESIDENTS OF BARANGAY 827, ZONE 89, DISTRICT V, APPROPRIATING FUNDS THEREFOR"

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1**. The Title of the City Ordinance No. 8257 is hereby amended, to read as follows:

"AN ORDINANCE EXPROPRIATING A CERTAIN PORTION OF A PARCEL OF LAND, SITUATED AT <u>DISTRICT OF PACO</u>, <u>CITY OF MANILA</u>, <u>ISLAND OF LUZON</u>, <u>BOUNDED ON THE NORTH WEST</u>, <u>ALONG LINE 1-2 BY LOT 19-B</u>, <u>OF THE SUBDIVISION PLAN; ON THE NORTH EAST</u>, <u>ALONG LINE 2-3 BY LOT 17</u>, <u>BLOCK 926</u>, <u>MANILA CADASTRAL ON THE SOUTH EAST</u>, <u>ALONG LINE 3-4 BY LOT 19-D</u>, <u>OF THE SUBDIVISION PLAN; AND ON THE SOUTH WEST</u>, <u>ALONG LINE 4-1 BY CALLE PEÑAFRANCIA</u>, OWNED BY SPOUSES CARLITO AND LIGAYA OSTANI, REGISTERED UNDER TRANSFER CERTIFICATE OF TITLE NO. <u>229658</u>, IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA, MEASURING APPROXIMATELY <u>FORTY-ONE SQUARE METERS AND FIFTEEN SQUARE DECIMETERS (41.15 SQ. M.)</u>, TO BE UTILIZED AS RIGHT-OF-WAY BY RESIDENTS OF BARANGAY 827, ZONE 89, DISTRICT V, APPROPRIATNG FUNDS THEREFOR"

**SEC. 2.** Section 1 of City Ordinance No. 8257 is hereby amended, to read as follows:

"SECTION 1. The expropriation of a certain portion of a parcel of land situated at <u>DIST. OF PACO, CITY OF MANILA, ISLAND OF LUZON, BOUNDED ON THE NW., ALONG LINE 1-2 BY LOT 19-B, OF THE SUBD. PLAN; ON THE NE., ALONG LINE 2-3 BY LOT 17, BLK., 926, MANILA CAD., ON THE SE., ALONG LINE 3-4 BY LOT 19-D, OF THE SUBD. PLAN; AND ON THE SW., ALONG LINE 4-1 BY CALLE PEÑAFRANCIA, owned by spouses Carlito and Ligaya Ostani, registered under TCT No. <u>229658</u> in the Registry of Deeds for the City of Manila is hereby authorized."</u>

**SEC. 3. Effectivity Clause.** - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 28, 2014.
