ORDINANCE NO. 8372

AN ORDINANCE INCREASING THE AMOUNT OF THE BARANGAY DEVELOPMENT FUND OR CITY AID GRANTED BY THE CITY GOVERNMENT OF MANILA TO ALL COMPONENT BARANGAYS WITHIN THE JURISDICTION OF THE CITY FROM ONE THOUSAND PESOS (PHP. 1,000.00), TO TWELVE THOUSAND PESOS (PHP. 12,000.00), PER FISCAL YEAR, APPROPRIATING THE AMOUNT OF TEN MILLION SEVEN HUNDRED FIFTY-TWO THOUSAND PESOS (PHP. 10,752,000.00), TO BE INCORPORATED UNDER THE BUDGETARY REQUIREMENTS FOR STATUTORY AND CONTRACTUAL OBLIGATIONS OF THE ANNUAL EXECUTIVE BUDGET OF THE CITY, AND FOR OTHER PURPOSES

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. The amount of Barangay Development Fund or City Aid granted by the City Government of Manila to all component barangays within its territorial jurisdiction is hereby increased from One Thousand Pesos (PhP. 1,000.00), to Twelve Thousand Pesos (PhP. 12,000.00), a year.


SEC. 2. The financial aid of the city corresponding to One Thousand Pesos (PhP. 1,000.00), per month or the aggregate amount of Twelve Thousand Pesos (PhP. 12,000.00), per year, shall be deposited in the account, and shall be credited under the general fund of the 896 component barangays of the city, to be released on a quarterly basis, and appropriated in the regular budget of the barangays in accordance with the existing accounting and regular auditing procedures.

SEC. 3. The sum of Ten Million Seven Hundred Fifty-Two Thousand Pesos (PhP. 10,752,000.00), is hereby appropriated out of the unappropriated funds of the city, and shall, for this purpose be incorporated under the budgetary requirements for Statutory and Contractual Obligations of the Annual Executive Budget of the City of Manila to complement the objective of the foregoing measure.

SEC. 4. Effectivity Clause. – This Ordinance shall take effect on January 1, 2015.

This Ordinance was finally enacted by the City Council of Manila on November 11, 2014.
