AN ORDINANCE ESTABLISHING A SUSTAINED FEEDING PROGRAM FOR ALL PRE-SCHOOL AND PRIMARY GRADE SCHOOL PUPILS IN ALL PUBLIC ELEMENTARY SCHOOLS IN THE CITY OF MANILA

It ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. A sustained feeding program for all pre-school and primary grade school pupils in all public elementary schools in the City of Manila shall hereby be established.

SEC. 2. The feeding program shall be implemented by the Office of the Mayor, Personnel of the City Health Office with the assistance of education officials of the city.

SEC. 3. Appropriation. - The amount as to much as may be necessary shall hereby be appropriated out of any unappropriated funds existing in the City Treasury to be made available for the implementation of this Ordinance.

SEC. 4. The Division of City Schools, together with the Manila Health Department, shall formulate the implementing rules and regulations upon approval of this Ordinance.

SEC. 5. Effectivity Clause. - This Ordinance shall take effect upon its approval.


This Ordinance was finally enacted by the City Council of Manila on November 6, 2014.


