ORDINANCE NO. 8404

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a. OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF FELIX HUERTAS, HERRERA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED, AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a. (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading area of Felix Huertas, Herrera Tricycle Operators & Drivers Association, Inc., (FELHERTODA), to read as follows:

“FELIX HUERTAS, HERRERA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC., (FELHERTODA)

Loading and Unloading Area

a. Felix Huertas Street - Herrera Street”

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Felix Huertas, Herrera Tricycle Operators and Drivers Association, Inc., to read as follows:



The authorized route line of operation shall be via Felix Huertas, Malabon, San Lazaro, Alvarez, E. Remigio, Mayhaligue, P. Guevarra, V. Fugoso, Lope de Vega, Quiricada, T. Mapua, Severino Reyes, Anacleto, M. Hizon, M. Natividad, Makata, and Kusang Loob Streets and vice-versa.”

SEC. 3. *Effectivity Clause.* – This Ordinance shall take effect upon its approval

This Ordinance was finally enacted by the City Council of Manila on August 13, 2015.


