ORDINANCE NO. 8405

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a. OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF SM SAN LAZARO, M. HIZON, LACSON, FELIX HUERTAS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED, AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading area of SM San Lazaro, M. Hizon, Lacson, Felix Huertas Tricycle Operators & Drivers Association, Inc., (MHILACFELTODA), to read as follows:

(MHILACFELTODA)**

Loading and Unloading Area

a. SM San Lazaro – Felix Huertas Street”

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of SM San Lazaro, M. Hizon, Lacson, Felix Huertas Tricycle Operators and Drivers Association, Inc., to read as follows:



The authorized route line of operation shall be via SM San Lazaro, M. Hizon, Lacson and Felix Huertas Streets and vice-versa.”


SEC. 3. *Effectivity Clause.* – This Ordinance shall take effect upon its approval

This Ordinance was finally enacted by the City Council of Manila on August 13, 2015.




