ORDINANCE NO. 8406

AN ORDINANCE AMENDING THE TITLE AND SECTION 2 OF ORDINANCE NO. 8274, ENTITLED: "AN ORDINANCE AUTHORIZING THE CITY MAYOR TO CAUSE THE ACQUISITION EITHER BY NEGOTIATION, EXPROPRIATION OR BY ANY OTHER LEGAL MEANS, OF THAT CERTAIN PARCEL OF LAND WITH AN AREA OF EIGHT HUNDRED NINETY-THREE SQUARE METERS AND TWENTY SQUARE DECIMETERS (893.20 SQ. M.), MORE OR LESS, LOCATED IN SAN ANDRES, MALATE, BARANGAY 738, ZONE 80, DISTRICT V, MANILA, REGISTERED UNDER THE NAME OF CARLOS TUASON, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 31697, IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA", BY APPROPRIATING THE AMOUNT OF FIVE MILLION THREE HUNDRED TWELVE THOUSAND PESOS (PHP. 5,312,000.00), OR SO MUCH AS MAY BE NECESSARY FOR THE IMPLEMENTATION THEREOF

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. The Title of Ordinance No. 8274 is hereby amended, which shall now read as follows:

"AN ORDINANCE AUTHORIZING THE CITY MAYOR TO CAUSE ACQUISITION EITHER BY NEGOTIATION. EXPROPRIATION OR BY ANY OTHER LEGAL MEANS, OF THAT CERTAIN PARCEL OF LAND WITH AN AREA OF EIGHT HUNDRED NINETY-THREE SQUARE METERS AND TWENTY SQUARE DECIMETERS (893.20 SQ. M.), MORE OR LESS, LOCATED IN SAN ANDRES, MALATE, BARANGAY 738, ZONE 80, DISTRICT V, MANILA, REGISTERED UNDER THE NAME OF CARLOS TUASON, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 31697, IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA, APPROPRIATING THE AMOUNT OF FIVE MILLION THREE HUNDRED TWELVE THOUSAND PESOS (PHP. 5,312,000.00), OR SO MUCH AS MAY BE NECESSARY FOR THE IMPLEMENTATION THEREOF"

- SEC. 2. Section 2 thereof is hereby amended, which shall now read as follows:
 - "SEC. 2. The amount of Five Million Three Hundred Twelve Thousand Pesos (PhP. 5,312,000.00), is hereby appropriated out of the unappropriated funds available in the City Treasury to ensure that the provisions of the Ordinance are carried out in accordance with its goals and objectives."
- **SEC. 3. Repealing Clause** All previous ordinances inconsistent with this Ordinance shall be deemed repealed or modified accordingly.
- SEC. 4. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on August 20, 2015.
