AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF MORONG MANUGUIT SUBDIVISION TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading area of Morong Manuguit Subdivision Tricycle Operators and Drivers Associations, Inc. (MMANSTODA), to read as follows:

“MORONG MANUGUIT SUBDIVISION TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC., (MMANSTODA)

Loading and Unloading Area

a. Morong Street near corner Pilar Street”

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Morong Manuguit Subdivision Tricycle Operators and Drivers Association, Inc., to read as follows:

ROUTE

Morong St. – Abad Santos LRT Station – Morong St. – Juan Luna St. and vice versa.”

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.


