ORDINANCE NO. 8408

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF CLARO M. RECTO – ANTONIO RIVERA – TUTUBAN TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED, AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Claro M. Recto – Antonio Rivera – Tutuban Tricycle Operators and Drivers Association, Incorporated (C.M. Recto – Tutuban TODA), to read as follows:

Loading and Unloading Areas

- a. Claro M. Recto corner Antonio Rivera Street
- b. Light Railway Station at Doroteo Jose Street corner Rizal Avenue”

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of the Claro M. Recto – Antonio Rivera - Tutuban Tricycle Operators and Drivers Association, Inc., to read as follows:



SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.


This Ordinance was finally enacted by the City Council of Manila on August 20, 2015.
