ORDINANCE NO. 8412

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a. OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF RAJAH ABAD SANTOS DELPAN ZARAGOSA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Rajah Abad Santos Delpan Zaragosa Tricycle Operators and Drivers Association, (RADELZATODA), to read as follows:

"RAJAH ABAD SANTOS DELPAN ZARAGOSA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (RADELZATODA)

Loading and Unloading Areas

- a. Zaragosa Road
- b. Delpan Road
- c. San Fernando Street (Rajah Abad Santos High School)"

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Rajah Abad Santos Delpan Zaragosa Tricycle Operators and Drivers Association, to read as follows:

"ASSOCIATION

R.M.C.

Rajah Abad Santos Delpan Zaragosa Tricycle Operators and Drivers Association (RADELZATODA) 150 Units

ROUTE

The authorized route line of operation shall begin in the area of Moriones Road to Asuncion St., to Wagas St., to Lualhati St., to Lakandula St., Kagitingan St., Zaragosa St. corner Pier North Harbor to Delpan Road corner C.M. Recto, Madrid St., Lavezares St., Muelle Industria St., to San Fernando St. and viceversa."

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval

This Ordinance was finally enacted by the City Council of Manila on August 25, 2015.
