**ORDINANCE NO. 8413**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a. OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF VENTURA FAJARDO SAMPALOC TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Ventura Fajardo Sampaloc Tricycle Operators & Drivers Association (VENFASAMODA), Inc., to read as follows:

**“VENTURA FAJARDO SAMPALOC TRICYCLE OPERATORS & DRIVERS ASSOCIATION (VENFASAMODA), INC.**

**Loading and Unloading Areas**

- a. Corner of H. Ventura and Sobriedad Street, Sampaloc, Manila
- b. Corner of T. Anzures and Matimyas Street, Sampaloc, Manila”

**SEC. 2.** Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Ventura Fajardo Sampaloc Tricycle Operators and Drivers Association, Inc., to read as follows:

**ROUTE**

The authorized route line of operation shall be via H. Ventura – Sobriedad Street – T. Anzures Street – Fajardo Street – S.H. Loyola Street and vice-versa.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect immediately upon its approval.


This Ordinance was finally enacted by the City Council of Manila on August 25, 2015.


