ORDINANCE NO. 8419

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BOHOL BLUMENTRITT MINDANAO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Bohol Blumentritt Mindanao Tricycle Operators and Drivers Association, Inc. (BOHOL BLUMIN TODA), to read as follows:

“BOHOL BLUMENTRITT MINDANAO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (BOHOL BLUMIN TODA)”

Loading and Unloading Areas

- a. Loading – corner of Bohol Street and G. Tuazon Street, Sampaloc, Manila
- b. Unloading – corner of Blumentritt Street and España Boulevard”

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Bohol Blumentritt Mindanao Tricycle Operators and Drivers Association, Inc., to read as follows:

<u>ASSOCIATION</u>	<u>R.M.C.</u>
Bohol Blumentritt Mindanao Tricycle Operators and Drivers Association, Inc. (BOHOL BLUMIN TODA)	24 Units

ROUTE

The authorized route line of operation shall be via Bohol Street to Blumentritt Street to Mindanao Street and vice versa.”

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.


