ORDINANCE NO. 8425

**AN ORDINANCE** IMPOSING MORATORIUM ON PAYMENTS OF FEES FOR STALLHOLDERS OF PUBLIC MARKET DISPLACED THROUGH IMPLEMENTATION OF CITY ORDINANCE NO. 8346, OTHERWISE KNOWN AS THE "MANILA JV ORDINANCE" AND THEIR IMPLEMENTING RULES AND REGULATIONS AND TO SUBMIT THE SAME FOR RATIFICATION BY THE CITY COUNCIL AND FOR OTHER PURPOSES

Be it ordained by the City Council of Manila, in session assembled, *THAT*:


**SECTION 1.** There shall be a moratorium on payment of fees of displaced stallholders of public markets subject of the Joint Venture Ordinance while all public markets are being constructed.

**SEC. 2.** Moratorium on payment of fees shall be lifted upon return of the displaced public market stallholders back inside the newly constructed public markets.

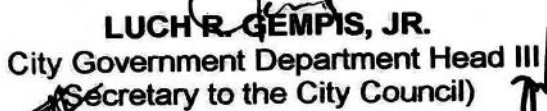
**SEC. 3. Effectivity Clause.** - This Ordinance shall take effect immediately upon its approval.
