ORDINANCE NO. 8427

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BARANGAY 199 ZONE 18 TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Barangay 199 Zone 18 Tricycle Operators and Drivers Association, Inc., to read as follows:

**"BARANGAY 199 ZONE 18 TRICYCLE OPERATORS AND DRIVERS
ASSOCIATION, INC.**

Loading and Unloading Areas

- a. Pilar – Hermosa going to Abad Santos LRT Station
- b. Pilar – Hermosa going to Juan Luna"

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Barangay 199 Zone 18 Tricycle Operators and Drivers Association, Inc., to read as follows:

<u>"ASSOCIATION</u>	<u>R.M.C.</u>
Barangay 199 Zone 18 Tricycle Operators and Drivers Association, Inc.	60 Units

ROUTE

The authorized route line of operation shall be via Pilar Street – Hermosa Street - LRT Station Abad Santos Ave. – Pilar Street – Hermosa – Juan Luna Gagalangin and vice versa."

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 13, 2015.
