ORDINANCE NO. 8428

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BINONDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Binondo Tricycle Operators and Drivers Association, Inc., (BINONDOTODA), to read as follows:

**“BINONDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC.
(BINONDOTODA)**

Loading and Unloading Areas

- a. Soler Street (Beside 999 Mall)
- b. Reina Regente Street (Infront of Lucky Chinatown)
- c. Meisic Street (Beside 168 Mall)”

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Binondo Tricycle Operators and Drivers Association, Inc., to read as follows:

“ASSOCIATION

Tricycle Operators and Drivers
Association, Inc.

120 Units


ROUTE

The authorized route line of operation shall be via San Fernando St. – Condesa St. – Ongpin St. – Dasmariñas St. – Benavides St. – Masangkay St. – Teodora Alonzo - F. Torres St. – Asuncion St. – Sto. Cristo St. – El Cano St. – Jaboneros St. – Lavesarez St. – Muelle De Binondo St. – Nomancia St. – Soler St. – Alvarado St. – Gandara St. – Nueva St. – Delpan St. – Madrid St. – Muelle De Industira and vice versa”

SEC. 3. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 1, 2015.
