ORDINANCE NO. 8436

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF STO. TOMAS VENTURA CALABASH TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading area of Sto. Tomas Ventura Calabash Tricycle Operators and Drivers Association, Inc., (STOVENCALATODA), to read as follows:

"STO. TOMAS VENTURA CALABASH TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (STOVENCALATODA)

Loading and Unloading Area

a. Sto. Tomas corner Josefina 1st Street."

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Sto. Tomas Ventura Calabash Tricycle Operators and Drivers Association, Inc., to read as follows:

<u>"ASSOCIATION</u>	<u>R.M.C.</u>
Sto. Tomas Ventura Calabash Tricycle Operators and Drivers Association, Inc. (STOVENCALATODA)	30 Units

ROUTE

The authorized route line of operation shall be via Sto. Tomas Street corner Josefina 1st Street, straight to Plaza Noli going to Ventura Street, left to Sobriedad Street, then right to Calabash Street and vice versa."

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


SEC. 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.
