ORDINANCE NO. 8444

AN ORDINANCE PROVIDING FOR AN INCREASE OF MONTHLY ALLOWANCES OF THE JUDGES, CLERKS OF COURT AND ASSISTANT CLERKS OF COURT OF THE REGIONAL TRIAL COURT AND THE METROPOLITAN TRIAL COURT OF THE CITY OF MANILA, AND PROVIDING FUNDS NECESSARY THEREFOR

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. The monthly allowances of the officials of the Regional Trial Court (RTC) and the Metropolitan Trial Court (MTC) of the City of Manila shall be increased as follows:

| 5. Clerk of Court, MTC | - from PhP. 10,000.00 to PhP. 12,000.00 |


SEC. 2. The amount of Fifteen Million Nine Hundred Fifty-Four Thousand Pesos (PhP. 15,954,000.00), is hereby authorized to be appropriated from funds available and not otherwise appropriated for the implementation of Section 1 of this Ordinance.

SEC. 3. Repealing Clause. – All ordinances or parts thereof which are inconsistent with this Ordinance or parts hereof are hereby repealed, amended or modified accordingly.


SEC. 4. Effectivity Clause. – This Ordinance shall take effect upon its approval.
