ORDINANCE NO. 8449

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF CAVITE AVENIDA TAMBUNTING TRICYCLE OPERATORS AND DRIVERS ASSOCIATION AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Cavite Avenida Tambunting Tricycle Operators and Drivers Association, (CATTODA), to read as follows:

"CAVITE AVENIDA TAMBUNTING TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (CATTODA)

Loading and Unloading Areas

- a. Cavite Street corner Rizal Avenue
- b. Bulacan Street corner Oroquieta Street"
- SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Cavite Avenida Tambunting Tricycle Operators and Drivers Association, to read as follows:

"ASSOCIATION

R.M.C.

Cavite Avenida Tambunting Tricycle Operators and Drivers Association (CATTODA)

50 Units

ROUTE

The authorized route lines of operation shall be via Cavite Street - Bulacan Street - Oroquieta Street - Tecson Street - M. Natividad Street - M. Hizon Street - Felix Huertas Street - Sulu Street - P. Guevarra Street - L. Rivera Street - SM San Lazaro - T. Mapua Street - Severino Reyes Street - Antipolo Street - Laguna Street - Batangas Street - Isagani Street - Tiago Street - Pampanga Street - Solis Street - Juan Luna Street - A. Maceda Street - Dinalupihan Street and vice versa."

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 24, 2015.
