ORDINANCE NO. 845D

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BLUMENTRITT FELIX HUERTAS PAMPANGA PEDRO GUEVARRA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Blumentritt Felix Huertas Pampanga Pedro Guevarra Tricycle Operators and Drivers Association, Inc., (BFPPTODA), to read as follows:

"BLUMENTRITT FELIX HUERTAS PAMPANGA PEDRO GUEVARRA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (BFPPTODA)

Loading and Unloading Areas

- a. Cavite Street corner Felix Huertas Street - Bulacan Street corner Felix Huertas Street
- b. Cavite Street corner Pedro Guevarra Street - Aurora Boulevard corner Pedro Guevarra Street"

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Blumentritt Felix Huertas Pampanga Pedro Guevarra Tricycle Operators and Drivers Association, Inc., to read as follows:

<u>"ASSOCIATION</u>	<u>R.M.C.</u>
Blumentritt Felix Huertas Pampanga Pedro Guevarra Tricycle Operators and Drivers Association, Inc. (BFPPTODA)	60 Units

ROUTE

The authorized route lines of operation shall be via Cavite Street – Bulacan Street - Felix Huertas Street - Pedro Guevarra Street - Pampanga Street - Aurora Boulevard and vice versa."

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 26, 2015.


