**ORDINANCE NO. 8467**

**AN ORDINANCE** AMENDING THE TITLE AND SECTION 2 OF CITY ORDINANCE NO. 8293, ENTITLED: "AN ORDINANCE AUTHORIZING THE CITY MAYOR TO CAUSE THE ACQUISITION EITHER BY NEGOTIATION, EXPROPRIATION OR BY ANY OTHER LEGAL MEANS, OF THAT CERTAIN PARCEL OF LAND WITH A TOTAL LAND AREA OF ONE THOUSAND SIXTY-FOUR SQUARE METERS (1,064 SQ.M.), MORE OR LESS, LOCATED IN BARANGAY 709, ZONE 78, AGNO STREET, MALATE, MANILA, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 47140, REGISTERED UNDER THE NAME OF EMILIA F. WARREN VDA. DE AGUILAR, IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA", BY APPROPRIATING THE AMOUNT OF FOUR MILLION TWO HUNDRED TWELVE THOUSAND TWO HUNDRED THIRTY-SEVEN PESOS (PHP. 4,212,237.00)

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** The Title of Ordinance No. 8293 is hereby amended, which shall now read as follows:

**“AN ORDINANCE AUTHORIZING THE CITY MAYOR TO CAUSE THE ACQUISITION EITHER BY NEGOTIATION, EXPROPRIATION OR BY ANY OTHER LEGAL MEANS, OF THAT CERTAIN PARCEL OF LAND WITH A TOTAL LAND AREA OF ONE THOUSAND SIXTY-FOUR SQUARE METERS (1,064 SQ.M.), MORE OR LESS, LOCATED IN BARANGAY 709, ZONE 78, AGNO STREET, MALATE, MANILA, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 47140, REGISTERED UNDER THE NAME OF EMILIA F. WARREN VDA. DE AGUILAR, IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA AND APPROPRIATING THE AMOUNT OF FOUR MILLION TWO HUNDRED TWELVE THOUSAND TWO HUNDRED THIRTY-SEVEN PESOS (PHP. 4,212,237.00), PURSUANT TO THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY OF MANILA.”**

**SEC. 2.** Section 2 thereof is hereby amended, which shall now read as follows:

**“SEC. 2. The amount of Four Million Two Hundred Twelve Thousand Two Hundred Thirty-Seven Pesos (PhP. 4,212,237.00), is hereby appropriated out of funds available and not otherwise appropriated, pursuant to the Land-for-the-Landless Program of the City of Manila.”**


**SEC. 3. Repealing Clause.** - All previous ordinances inconsistent with this Ordinance shall be deemed repealed or modified accordingly.

**SEC. 4. Effectivity Clause.** - This Ordinance shall take effect upon its approval.



This Ordinance was finally enacted by the City Council of Manila on October 27, 2015.




