ORDINANCE NO. 8469

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF MASANGKAY IPIL BAMBANG TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Masangkay Ipil Bambang Tricycle Operators and Drivers Association (MIBTODA), Inc., to read as follows:

"MASANGKAY IPIL BAMBANG TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (MIBTODA), INC.

Loading and Unloading Areas

- a. Jose Abad Santos Ave. corner Bambang Street
- b. Fermin Tubera Street corner Bambang Street
- c. Yakal Street corner Bambang Street
- d. Felix de Leon Street corner Bambang Street
- e. Masangkay Street corner Bambang Street
- f. Ipil Street corner Dizon Street
- g. Ipil Street corner Alvarez Street"

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Masangkay Ipil Bambang Tricycle Operators and Drivers Association, Inc., to read as follows:

"ASSOCIATION

R.M.C.

Masangkay Ipil Bambang
Tricycle Operators and Drivers
Association, Inc.
(MIBTODA)

40 Units

ROUTE

The authorized route lines of operation shall be via Bambang Street - Quiricada Street - Antonio Rivera Street - Mayhaligue Street - Severino Reyes Street - Tomas Mapua Street - Felix Huertas Street - Oroquieta Street - Remegio Street - Fugoso Street - Soler Street and vice versa."


SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.


This Ordinance was finally enacted by the City Council of Manila on February 9, 2016.




