ORDINANCE NO. 8471

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF SM-SAN LAZARO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of SM-San Lazaro Tricycle Operators and Drivers Association (SM-SLTODA), Inc., to read as follows:

"SM-SAN LAZARO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (SM-SLTODA), INC.

Loading and Unloading Areas

- a. From Felix Huertas Street near the corner of Tayabas Street (Northbound lane), to Felix Huertas Street corner Vertex Road
- b. Felix Huertas Street corner Laguna Street
- c. Felix Huertas Street corner MJC Drive"

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of SM-San Lazaro Tricycle Operators and Drivers Association, Inc., to read as follows:


ROUTE

The authorized route line of operation shall begin in the area of Felix Huertas St. - Tomas Mapua St. - Oroquieta St. - Bambang St. - Quiricada St. - Fugoso St. - Masangkay St. and vice versa".

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.
