**ORDINANCE NO. 8472**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF VICENTE ESPAÑA DELA FUENTE LEPANTO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Vicente España Dela Fuente Lepanto Tricycle Operators and Drivers Association, Inc., (VEDELTODA), to read as follows:

**"VICENTE ESPAÑA DELA FUENTE LEPANTO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (VEDELTODA)**

**Loading and Unloading Areas**

- a. M. Dela Fuente St. cor. España Blvd.
- b. S.H. Loyola St. cor. M. Dela Fuente St.
- c. Vicente Cruz St. cor. S.H. Loyola St."

**SEC. 2.** Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Vicente España Dela Fuente Lepanto Tricycle Operators and Drivers Association, Inc., to read as follows:

**ROUTE**

The authorized route lines of operation shall be via M. Dela Fuente St. cor. España Blvd. - S.H. Loyola St. cor. M. Dela Fuente St.- Vicente Cruz St. cor. M. Dela Fuente St. and vice versa."

**SEC. 3. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on February 11, 2016.
