ORDINANCE NO. 8479

AN ORDINANCE FURTHERMORE AMENDING SECTION 2a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF UNITED NATIONS OTIS CRISTOBAL PACO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2 a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of United Nations Otis Cristobal Paco Tricycle Operators and Drivers Association (UNOCRISPATODA), Inc., to read as follows:

"UNITED NATIONS OTIS CRISTOBAL PACO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (UNOCRISPATODA), INC.

Loading and Unloading Areas

- a. Cristobal Street
- b. Unilever Cristobal Street corner United Nations Avenue
- c. Mendoza Street corner Otis Street
- d. Paz Street corner Quirino Extension"

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of United Nations Otis Cristobal Paco Tricycle Operators and Drivers Association, Inc., to read as follows:

"ASSOCIATION

R.M.C.

United Nations Otis Cristobal Paco
Tricycle Operators and
Drivers Association, Inc.
(UNOCRISPATODA)

65 Units

ROUTE

The authorized route line of operation shall begin in the area of Cristobal St. - United Nations Avenue - Cristobal Ext. - Zulueta St. - Paz St. - Apacible St. - Angel Linao St. - Perez St. - Belen St. - Romualdez St. - General Luna Ave. and vice versa."

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 1, 2016.
