**ORDINANCE NO. 8496**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2a OF ORDINANCE NO 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF MACEDA LOYOLA FAJARDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, **THAT**

**SECTION 1.** Section 2 a (Tricycle Terminals) of Ordinance No 7755, is hereby furthermore amended, by including therein the loading and unloading areas of Maceda Loyola Fajardo Tricycle Operators and Drivers Association, Inc. (MALOFATODA), to read as follows:

**“MACEDA LOYOLA FAJARDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (MALOFATODA)**

**Loading and Unloading Areas**

- a Loading – corner of España Boulevard and Maceda Street, Sampaloc, Manila
- b Unloading – corner of G Tuazon Street and Antipolo Street, Sampaloc, Manila”

**SEC. 2.** Section 2 of Ordinance No 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Maceda Loyola Fajardo Tricycle Operators and Drivers Association, Inc., to read as follows.

**“ASSOCIATION**

**R.M.C.**

Maceda Loyola Fajardo  
Tricycle Operators and Drivers  
Association, Inc  
(MALOFATODA)

30 Units

**ROUTE**

The authorized route line of operation shall be via Maceda Street – Matimyas Street – Fajardo Street – Antipolo Street and vice versa ”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect immediately upon its approval.
