**ORDINANCE NO. 8500**

**AN ORDINANCE** FURTHER AMENDING SECTION 1 OF ORDINANCE NO. 7987 AS AMENDED BY ORDINANCE NO. 8044, BY INCLUDING THE PUBLIC HEALTH WORKERS IN THE CLINIC OF UNIVERSIDAD DE MANILA, IN THE IMPLEMENTATION OF THE RELEVANT PROVISIONS OF REPUBLIC ACT 7305, OTHERWISE KNOWN AS THE MAGNA CARTA OF PUBLIC HEALTH WORKERS, SO AS TO PROVIDE FOR RETIREMENT PAY, HAZARD ALLOWANCE, LONGEVITY PAY AND OVERTIME PAY

Be it ordained by the City Council of Manila, in session assembled, THAT:


**SECTION 1.** Section 1 of Ordinance No. 7987 as amended by Ordinance No. 8044 is hereby further amended, to read as follows:

**"SECTION 1.** The implementation of relevant provision of R.A. 7305, otherwise known as the Magna Carta of Public Health Workers, so as to provide for retirement pay, hazard allowance, longevity pay, and overtime pay of Public Health Workers in the Manila Health Department, the four (4) City Government hospitals namely: the Ospital ng Maynila Medical Center, the Gat Andres Bonifacio Memorial Medical Center, the Ospital ng Sampaloc and the Ospital ng Tondo and the **Clinic of Universidad de Manila (UDM)**, is hereby authorized."


**SEC. 2.** This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 6, 2016.
