## ORDINANCE NO. 8504

AN ORDINANCE AUTHORIZING THE ALLOCATION OF THE OTHER MAINTENANCE AND OPERATING EXPENSES, UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES OF THE CITY DEVELOPMENT OFFICE, DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT – NATIONAL CAPITAL REGION, IN THE AMOUNT OF ONE HUNDRED TWENTY THOUSAND PESOS (PHP. 120,000.00), TO BE USED AS PAYMENT FOR THE ALLOWANCES OF THE CITY DIRECTOR

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1.** It is the declared policy of the City Government of Manila when its finances so allow, to provide allowances and benefits to officials of the National Government stationed in or assigned to the city, aimed at strengthening their capabilities towards delivery of effective and necessary services to the people of Manila.

- **SEC. 2.** Pursuant to the stated policy, the following remunerations shall be provided:
  - a) Monthly allowance for the City Director (DILG-NCR) (PhP. 10,000.00 x 12 months)

- SEC. 3. The amount of One Hundred Twenty Thousand Pesos (PhP. 120,000.00), is hereby authorized and allocated, to be sourced and taken from the Non-Office (Statutory and Contractual Obligations) funded under Ordinance No. 8442, FY 2016, to be used as payment for the allowances of the City Director (DILG-NCR) in accordance with the accounting and auditing rules and regulations.
- **SEC. 4. Effectivity Clause.** This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 18, 2016.
