ORDINANCE NO. 8507

AN ORDINANCE AUTHORIZING THE INCREASE OF THE MONTHLY ALLOWANCES OF THE CITY PROSECUTOR, DEPUTY PROSECUTORS. SENIOR ASSISTANT CITY **PROSECUTORS** AND ASSISTANT CITY PROSECUTORS OF THE OFFICE OF THE CITY PROSECUTOR OF MANILA, AMENDING FOR THIS PURPOSE CITY ORDINANCE NO. 8453, AND PROVIDING THE FUNDS NECESSARY THEREFOR

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. The policy of the City Government to provide special remunerations to the Office of the City Prosecutor of Manila in the performance of its functions of investigating criminal complaints and prosecuting criminal cases in courts is hereby reiterated.

SEC. 2. The monthly allowances of the City Prosecutor, Deputy City Prosecutors, Senior Assistant City Prosecutors and Assistant City Prosecutors of the Office of the City Prosecutor of Manila shall be increased, to wit:

SEC. 3. The amount of TWENTY-ONE MILLION NINETY-SIX THOUSAND PESOS (Php. 21,096,000.00) is hereby authorized and allocated, to be sourced and taken from the Non-Office (Statutory and Contractual Obligations) Fund of the Office of the Mayor, for the payment of the monthly allowances, as increased, of the City Prosecutor, Deputy City Prosecutors, Senior Assistant City Prosecutors and Assistant City Prosecutors, broken down as follows:
