AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED FORTY-EIGHT MILLION SEVEN HUNDRED TWENTY-FOUR THOUSAND FOUR HUNDRED ONE PESOS (PHP. 248,724,401.00), REPRESENTING THE TOTAL AMOUNT DERIVED FROM SALARY SAVINGS OF THE DIFFERENT DEPARTMENTS/OFFICES/BUREAUS AND RETIREMENT GRATUITY (RETIREMENT BENEFITS-CIVILIAN-NON-OFFICE) FOR THE PROPOSED PAYMENT OF 14TH MONTH PAY EQUIVALENT TO ONE (1) MONTH SALARY OF THE EMPLOYEES OF THE CITY GOVERNMENT

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. There is hereby reverted the sum of Two Hundred Forty-Eight Million Seven Hundred Twenty-Four Thousand Four Hundred One Pesos (PhP. 248,724,401.00), representing the total amount derived from Salary Savings of the different departments/offices/bureaus and retirement gratuity (Retirement Benefits-Civilian-Non-Office), under Ordinance No. 8442 as the Executive Budget for FY 2016.

SEC. 2. The sum herein reverted represents the total amount derived from reversion of a portion from Retirement Benefits-Civilian-Non-Office and from Salary Savings of departments/offices/bureaus from January 1, 2016 to August 31, 2016, as follows:
