**ORDINANCE NO. 8513**

**AN ORDINANCE** AUTHORIZING THE GRANT OF MONTHLY INCENTIVE ALLOWANCE TO ALL LAWYERS OF THE PUBLIC ATTORNEY'S OFFICE ASSIGNED/BASED IN THE CITY PROVIDING FREE LEGAL ASSISTANCE TO THE RESIDENTS THEREAT, APPROPRIATING ANNUALLY THE AMOUNT OF SEVEN MILLION TWO HUNDRED THOUSAND PESOS (PHP. 7,200,000.00) FOR THE PURPOSE

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** It is the declared policy of the City Government of Manila when its finances so allow, to provide allowances and benefits to officials of the National Government stationed in or assigned to the City, aimed at strengthening their capabilities towards delivery of effective and necessary services to the people of Manila.

**SEC. 2.** The Implementing Rules and Regulations of Republic Act 9406, otherwise known as, "An Act Reorganizing and Strengthening the Public Attorney's Office (PAO), amending for the purpose pertinent provisions of Executive Order No. 292, otherwise known as the "Administrative Code of 1987", as amended, granting special allowance to PAO Officials and Lawyers and providing funds therefor," provides that under, Rule XII, Section 39, the Local Government Units, subject to their capabilities, may extend financial and other support in the form of honoraria, free office space, equipment, furniture, stationery and manpower to the PAO.

**SEC. 3.** Pursuant to the stated policy, the following remunerations shall be provided:

**SEC. 4.** The amount of Seven Million Two Hundred Thousand Pesos (PhP. 7,200,000.00), may be authorized and allocated, to be sourced and taken from the Non-Office (Statutory and Contractual Obligations) Fund for the payment of the monthly incentive allowances to all lawyers of the Public Attorney's Office (PAO) assigned/based in the City providing free legal assistance to the residents thereat.

**SEC. 5.** Any and all ordinances that are inconsistent with any provision of this Ordinance are hereby repealed/modified accordingly.


**SEC. 6. Effectivity Clause.** - This Ordinance shall take effect on January 2017.

This Ordinance was finally enacted by the City Council of Manila on December 15, 2016.
